20 Held Saturday, April 13, 13

The special meeting was called to order at 8:00am by Chairman Andy Bushman with Trustees Todd Ray and Irene McMullen, Fiscal Officer Judy Toth, and Architect Hank Penttila present. The meeting opened with the Pledge of Allegiance. Correspondence was on the table.

INTERVIEWS FOR CONSTRUCTION MANAGER AT RISK

Architect Hank Penttila sent a list of questions to the candidates prior to the interviews. They were asked to explain their bids, how they see the project, their methods, means and pricing, and to make value engineering recommendations. He was surprised to find quite a spread over the various bids, as the specifications were well defined. For mechanical, electrical, site, and plumbing, there was a wide disparity. Enzoco did not include the construction manager fee in the quote. Hank raised the option of negotiating the construction manager fee separate from the construction cost.

The Trustees interviewed Construction Manager at Risk candidates, Welty Building Company and Erie Affiliates. Each interview lasted approximately one hour. The final two candidates will be interviewed on Tuesday, April 16.

Hank suggested that a landscape architect do a site review and make recommendations for plantings at a cost of \$1,000. Hank will hire the landscape architect and invoice the township. Todd Ray moved and Irene McMullen seconded to authorize Hank Penttila to have landscape architect work done relevant to the town hall project not to exceed \$1,000, with a unanimous vote. Motion carried.

RESOLUTION 2013-14/FUND TRANSFER

Resolution 2013-14 was made by Todd Ray and seconded by Irene McMullen for within fund transfers in the General Fund, with a unanimous vote. Motion carried. [The resolution in its entirety is included on a separate page as part of the minutes.]
