INTERVIEWS FOR CONSTRUCTION MANAGER AT RISK

The Trustees interviewed Construction Manager at Risk candidates, Enzoco Homes, and Cold Harbor Building Company. Each interview lasted approximately one hour.

Hank Penttila will ask for breakdowns and a list of subcontractors from the companies that did not provide them. After the Trustees agree upon their first choice for construction manager, the architect will meet with the candidate to go over the individual quotes. The Trustees will then have the option to award the contract or move to the next candidate.

RESOLUTION 2013-15/FUND TRANSFER

The architect has already prepared the specifications.
