MUNSON TOWNSHIP TRUSTEES SPECIAL

Meeting

Held Tuesday, August 20, 20 13

The meeting was called to order at 6:30pm by Chairman Andy Bushman with Trustees Todd Ray and Irene McMullen and Fiscal Officer Judy Toth present. The Chairman led the Pledge of Allegiance. Warrants 11585-11613 dated 8/20/13 totaling \$172,528.53 were signed. Warrants 11605-11606 were voided due to a printing error.

TOWN HALL PROJECT

Architect Hank Penttila asked for the Board's decision on a window wall from the Trustees meeting room into the receptionist area at an estimated cost of \$3,876. The Trustees will reserve judgment until after the walk through. The architect will need a decision on the color for the standing seam roof for the cupola and for the stucco and hardy plank. The existing stucco on the fire station will be repainted to match the new construction. The architect advised that the stucco color should be chosen with care as it will pull together the roof color, trim and existing stone. He suggested a warmer light gray to match the stone. Samples will be provided and an area painted on the outside surface of the building for the trustees to view. Decisions will be made at the next meeting.

ROAD DEPARTMENT

Road Superintendent Jim Teichman asked the board to authorize a background check as the next stop in hiring seasonal employee Doug Cross for full time employment. Doug is preparing to take his Class B CDL and will take additional classes to qualify for Class A. Based on Mr. Teichman's recommendation, the Board agreed to move forward with the background checks. Todd Ray moved and Irene McMullen seconded to authorize the office manager to proceed with background check processing for Douglas Cross, with a unanimous vote. Motion carried. The Trustee signed the CIR, Inc. proposal to install two cross culverts on Sherman Road, which was approved at the last meeting. Mr. Teichman asked the Board to encumber \$1,162 to McGill Septic Tank Company for the headwalls, and \$9,630 to Rinker Materials for the elliptical pipe. Rinker will include the tar and the glue for the gaskets.

Todd Ray moved and Irene McMullen seconded to approve the purchase of concrete headwalls for Sherman Road from McGill Septic Tank Company not to exceed \$1,162, with a unanimous vote. Motion carried.

Todd Ray moved and Irene McMullen seconded to authorize the purchase of 64 feet of 42 inch pipe and 64 ft. of elliptical pipe from Rinker Materials not to exceed \$9,630, with a unanimous vote. Motion carried.

Mr. Teichman contacted the county engineer. They will look at the bridge on Sherman close to Heath Road. If it has ten years or less of life expectancy, they will replace it as part of the township project. Mr. Teichman observed that the current bridge may not be wide enough when the road is resurfaced.

CEMETERY STONE REPLACEMENT

Mr. Teichman discussed replacing some of the broken and illegible headstones at the township cemeteries. Sheffield Monuments is offering a program to replace veterans' stones in groups of 17 at a cost of \$350 per stone for a 2 ft x 1 ft 2 inch thick stone with lettering included. The stones can be ordered as needed and picked up at the township's convenience. Claridon Township is considering a similar program. Cemetery Director, Paula Friebertshauser, has also contacted an expert in Connecticut regarding refurbishing the existing stones. The road department resets approximately ten foundations a year as part of the general upkeep of the cemeteries. The township has stones from private cemeteries, Rider (formerly located at Tall Pines), Brewster (Bean Road), and one stone from the center of the intersection of Parkside and Basswood Roads that need to be placed in the township cemeteries.

TOWN HALL BUILDING SITE TOUR

Architect Hank Penttila led the Trustees and those in attendance on a tour of the building site. Construction managers Enzo and Joe Perfetto were present. In the new lobby, up-lighting will be provided at the ten foot four inch height ceiling around the perimeter. Because it is an interior lobby, the cupola was designed to provide some natural light. The cupola will also serve as a landmark for the township's government. A three unit window was added to the interior wall of the caucus room to provide a view of the outside and to bring natural light into the lobby. The door to the caucus room will have one side light. A larger door was provided from the lobby to the community room storage room for easier access to supplies. The architect was pleased with the size and scale of the community room. The soffits and fire wall for the ceiling were in. There will be an acoustical drop ceiling six inches below the firewall. If the trustees approve the expense, an additional sidelight will be added to the entry door from the lobby to the township offices at a cost of \$764. The Trustees looked at the interior lobby for the administrative offices.

The existing block walls in the offices will be covered with drywall. The contractor will get an estimate to cover the block wall in the administrative lobby. Outside the building, the trustees looked at color samples for the metal roof for the cupola. The walk-through ended at 7:50pm. Todd Ray moved and Irene McMullen seconded to approve \$764 for the additional sidelight for the entry door into the administrative lobby, with a unanimous vote. Motion carried. Burgundy was selected for the cupola roof. The trustees did not approve the window wall between the township meeting room and the administrative lobby. The architect will provide samples of paint for the stucco exterior.

CONTRACTS FOR MICROSURFACING, RESURFACING, & MILLSTONE CULVERT

The Trustees received the engineer's recommendations for micro-surfacing, asphalt resurfacing and replacement of the Millstone Drive culvert.

Todd Ray moved and Irene McMullen seconded to award the contract for the micro-surfacing of various roads to Strawser Construction, Inc. for \$116,700, with a unanimous vote. Motion carried.

Todd Ray moved and Irene McMullen seconded to award the contract for the asphalt resurfacing of various roads to Carron Asphalt Paving Inc. for \$249,737.50, with a unanimous vote. Motion carried.

Todd Ray moved and Irene McMullen seconded to award the contract for the Millstone Drive culvert replacement to Leon Riley, Inc. for \$44,947, with a unanimous vote. Motion carried. <a href="https://example.com/resolvert/replacement-noise.com/resolvert/re

Todd Ray moved and Irene McMullen seconded to approve the change of date for rental of the Emmons Pavilion from September 6, 2013 to September 27, 2013 for the Geauga Rehabilitation Engineering Company Outing (Naft) at 3pm, approx. 25, with a unanimous vote.
