Tuesday, August 26, 20 14 Held

The meeting was called to order at 6:30pm by Chair Irene McMullen with Trustees Andy Bushman and Jim McCaskey and Fiscal Officer Judy Toth present. The Chairman led the Pledge of Allegiance. The Trustees signed warrants 12537-12584 dated 8/26 and 8/29/14 totaling \$137,475.99, EFT Vouchers 329-344 for the 8/29/14 monthly and bi-weekly payrolls in the amount of \$18,047.98, and warrant 1188 dated 8/26/14 in the amount of \$8,172.78 to transfer EMS collections from the lockbox. Warrant 12321 was voided.

Andy Bushman moved and Jim McCaskey seconded to approve the August 12, 2014 minutes as written, with a unanimous vote. Motion carried.

DEPUTY REPORT

Sheriff's Deputy Steve Savor reported on speed conditions on Woodiebrook Road and ATV activity on Burlington Ridge and Burlington Glen. Now that school is in session, he is watching for student speeding. He advised that the county engineer placed several speed boxes on Woodiebrook Road in response to the Trustees request for a speed study. The Trustees asked him to patrol Fowlers Mill Road as the bridge project will not be completed until September. EXECUTIVE SESSION FOR PENDING LITIGATION AND PERSONNEL DISCIPLINE Andy Bushman moved and Jim McCaskey seconded to go into executive session at 6:38pm to discuss pending litigation and personnel discipline, with a unanimous vote. Motion carried. The regular session resumed at 7:03pm.

WOODIEBROOK ROAD

Resident John Mihalik suggested that part of the problem at the "S" curves on Woodiebrook Road was the negative pitch, which causes vehicles to slide off the road and to drive left of center. He said that the cars are not speeding, but as they come over the rise, the road drops away, and the right front wheel lifts off the pavement. Both edges have the same negative pitch, affecting traffic in both directions. Mr. Mihalik contacted the engineer's office with his concerns. The engineer will require an official letter from the Trustees before he will proceed. Andy Bushman moved and Jim McCaskey seconded to authorize a letter to have the county engineer look at the pitch of the property on Woodiebrook Road, with a unanimous vote. Motion carried.

COUNTRY OAKS DRAINAGE

Road Superintendent Jim Teichman advised that there will be a slight delay in the installation of the Niedenbergers' pipe to allow Time Warner to relocate its cable to the back side of the ditch.

DITCH ENCLOSURE POLICY

Superintendent Teichman informed the Board that the county has a ditch enclosure maintenance plan, which they will forward to the township. Mr. McCaskey advised he also contacted ODOT for a copy of their policy.

ROAD REPORT/TEICHMAN

Cross Vacation

Doug Cross was authorized to use accrued vacation leave prior to his one-year anniversary, and is asking for one additional day.

Andy Bushman moved and Jim McCaskey seconded to allow Doug Cross to take an additional day September 15th before his anniversary date, with a unanimous vote. Motion carried. **Trailer Shipping**

The cost to ship the new trailer will be \$1,100. The cost was reduced from \$1,700 as the expense will be shared for part of the distance.

Andy Bushman moved and Jim McCaskey seconded to authorize \$1,100 to Behnke Enterprises to ship the trailer, with a unanimous vote. Motion carried.

Dozer Rental

Mr. Teichman requested \$460 to rent a bulldozer for the new section of Fowlers Mill Cemetery. The area is rocky and he has been using topsoil as it becomes available to level the cemetery,. Mr. McCaskey suggested that the town hall be done at the same time. The location for the new playground is in the landscape plan. Two days rental will be placed on the encumbrance sheet. Andy Bushman moved and Jim McCaskey seconded to allow bulldozer rental not to exceed \$920, with a unanimous vote. Motion carried.

Fire Department Electrical Supply Box

The breakers in the electrical supply box in the fire station bay are obsolete and are expensive to replace. Mr. Teichman will get quotes to replace the box.

Sherman Road Construction Easement

Mr. Teichman is waiting for a response from the property owners regarding construction easements for the Sherman Road pipe job.

ROAD REPORT (continued)

Park Vandalism

The parks have sustained sizeable damage to the picnic tables. The road department is repairing an average of one per week due to jumping on the seats. The road department will reinforce the seats with an additional 2×6 and double the bolts in an attempt to preserve the tables. The toilet paper dispenser was dismantled in the ladies restroom at Scenic River. The deputy has been asked to make additional patrols at the parks.

Handicap Access to Scenic River Men's Restroom

Mr. McCaskey followed up on the park board's concern with handicap access in the men's restroom at Scenic River. Mr. Bushman said the Department on Aging checked the door, and the space is tight but accessible. Mr. Bushman and resident Walter Leagan will take a wheelchair to the park to make an additional check.

FIRE DEPARTMENT MOLD REMEDIATION/ROOF INSULATION

Fire Chief Mark Lynn reported that Precision Environmental did the attic portion of the mold remediation today. The maintenance room will be done tomorrow. Boak is estimating the insulation cost for the fire station and town hall.

AUDIT COMMITTEE MEETING

The Audit Committee will meet September 9, 2014 at 5:30pm prior to the Trustees meeting. Audit Committee member Trevor Wilson is available to attend.

CEMETERY RESTORATION

The Trustees reviewed a quote from Stonehuggers for cemetery stone restoration submitted by Sexton Paula Friebertshauser. Mr. McCaskey suggested that \$10,000 be placed in the township budget for each of the next two years. Mr. Teichman was given a copy of the proposal and was advised that the company is currently working in three townships in the area if he wants to view its work.

PASSPORT PROGRAM CERTIFICATION

Mrs. McMullen will attend training in November to be certified in the ODNR Division of Wildlife's Passport Program. Once she is certified, free fishing poles will be made available to the township to be given away. She invited the other trustees to attend if they were interested.

ZONING BULLETIN

Andy Bushman moved and Jim McCaskey seconded to renew the Zoning Bulletin subscription for the Zoning Commission, with a unanimous vote. Motion carried.

RESOLUTION 2014-37/FUND CERTIFICATION AND TRANSFER

Andy Bushman moved and Jim McCaskey seconded to certify \$500.00 received from the Ohio Department of Natural Resources Division of Wildlife for the Fishing Derby and to place it in the Permanent Appropriation and for within fund transfers in the General Fund and Road and Bridge Fund, with a unanimous vote. HEALTHY MUNSON/ROIZEN EVENT

Mrs. McMullen attended an organizational meeting today for the Healthy Munson Roizen event to be held at Notre Dame on October 21st. Notre Dame has the event very well organized. The Cleveland Clinic is requesting volunteers to man the registration table and the township staff will be asked to participate. The trustees and fiscal officer also offered to help. The health fair screenings will be at 5:30pm and Dr. Roizen will speak from 7-8:30pm.

TOWN HALL PLAYGROUND

Fairmount Minerals is in the process of restructuring their company, but assured Mrs. McMullen that they still planned to contribute to the cost of the new playground and to provide volunteers for its installation. The Trustees will review the two latest proposals from Meyer Design and Park and Play Structures for a decision at the next meeting. Both companies agreed to adjust the cost to accommodate volunteers and are flexible on color selection. The road superintendent was authorized to remove the old playground equipment. He inquired about drainage and advised it would be necessary to reshoot the grade. The old playground equipment will be labeled and stored.

BASEBALL LEAGUE MEETING

A meeting will be scheduled with the Baseball League September 23 at 6pm prior to the Trustees meeting.
