Chairman Andy Bushman called the meeting to order at 6:30pm, with Trustees Jim McCaskey and Irene McMullen and Fiscal Officer Judy Toth present. Mr. Bushman led the Pledge of Allegiance. The Board signed warrants 16236-16276 dated 12/11 and 12/28/2018 totaling \$184,061.45; EFT Vouchers 459-467 for the 12/14/18 bi-weekly payroll totaling \$9,248.07; and warrant 1285 for \$12,972.48 to transfer EMS collections from the lockbox.

#### **MINUTES**

Irene McMullen moved and Jim McCaskey seconded to approve the minutes of November 27, 2018, with a unanimous vote. Motion carried.

#### TOWN HALL WELL UPDATE

The well is not going to come back. Mr. McCaskey will file with the EPA to see what the next step is.

#### **PUBLIC COMMENT**

Chief Alan Zwegat read a prepared statement expressing his outrage over a perceived insult to the fire department that took place prior to the road department luncheon. Residents Todd and Mary Ray asked if the Boy Scout troop had preferred status on room rental requests, and if so, why. They also wanted to know if other requests would continue to be secondary. Mrs. McMullen reviewed areas that were under consideration in the room use policy, and asked if the Rays wanted to be notified, should one of the dates they requested become available. Mr. McCaskey noted that the Boy Scout Troop has been under the umbrella of the Fire Department for many years. Mrs. Ray told him that their 4H organization has 77 members and there are very few places that they can meet. Resident Tom Norton asked if the Trustees had made a decision on closing the recycling site. In early October, the Trustees set December 31 as the deadline. Mrs. McMullen explained what the Board had been doing to educate residents to recycle responsibly. She believed most residents were incredibly responsible and were using the center appropriately. However, some still used it as a dumping ground. Recently, Formica materials, an aquarium, and furniture were placed in the dumpster. If a load is too contaminated, everyone's contributions go to the landfill. The Board had been hoping to keep the center open and has had difficulty in coming up with another solution. With curbside recycling, there is more of a check on what people are recycling. The Board can terminate its contract with Geauga Trumbull with a 30-day notice. Mr. Bushman spoke to all of the local waste haulers and provided a list of companies that offer curbside recycling in the last newsletter, along with the cost. Mr. Norton said the problems were more obvious with the leaves off the trees, and pressed for a decision that evening.

#### FIRE DEPARTMENT/CHIEF ALAN ZWEGAT

Chief Zwegat reported that the men's restroom renovation is going well and should be completed in the next week and a half. The bucket truck is back in service. The engine's head gasket leak will go in for warranty repair on Monday. They sold Rescue 4071 and will sell the Zodiac to Fairport Harbor after the first of the year. They accepted a \$2,000 offer. The Zodiac is on the Fire Department inventory. The Fire Department wanted to loan several pieces of equipment to the Road Department, including a jackhammer and chain saw, which are not used by the Fire Department on a regular basis. The items should be used to keep them in good working order. The equipment will still be available to the Fire Department if needed. He asked the Trustees to sign for the equipment to give the Township the authority to use them and to place them on the Township's inventory. Mrs. McMullen suggested consulting the prosecutor's office before signing a document. The Chief said a motion would be sufficient. Jim McCaskey moved and Andy Bushman seconded to accept the loaned equipment from the Fire Department to the Road Department, with a unanimous vote. Motion carried. A list of the items was provided to the Road Department.

#### RESOLUTION 2018-56/CONVENIENCE AND NECESSITY/WEXFORD AND CHELSEA

Resolution 2018-56 was made by Irene McMullen and seconded by Jim McCaskey that public convenience and welfare require the improvement of Wexford Road and Chelsea Drive in Munson Township, and to authorize the county engineer to prepare engineering plans, with a unanimous vote. Motion carried.

#### **ROAD REPORT/SUPERINTENDENT JIM TEICHMAN**

Mr. Teichman is pricing snow guard for maintenance building #1. River, Epping, Woodhollow and Sun Ridge Circle are scheduled to be resurfaced in 2020. If funds are available, Mr. Teichman asked if the Board would like to include River and Epping in the 2019 projects. Mr. McCaskey will look at the roads for a decision at the next meeting. He was working with Mr. Teichman to get estimates for an electrical engineer for the fueling station. It was difficult to find an engineer willing to take on a small project, and he suggested that the Board accept Tech, Inc.'s quote. The cost will be between \$1,500 and \$2,000.

Irene McMullen moved and Jim McCaskey seconded to use Tech, Inc. for engineering in an amount not to exceed \$2,000, with a unanimous vote. Motion carried.

#### ORGANIZATIONAL MEETING

Irene McMullen moved and Jim McCaskey seconded to hold an organizational meeting on Tuesday, January 1, 2018 at 6:30pm and to include other regular business, with a unanimous vote. Motion carried.

#### **FIRE CONTRACT**

The Trustees received a draft of the Fire Contract with the Prosecutor's comments, and will set up a workshop with the Fire Department prior to the December 27 meeting.

Irene McMullen moved and Jim McCaskey seconded to have a special meeting to discuss Fire Department matters at 5:30pm on December 27, 2018 with the regular meeting to follow, with a unanimous vote. Motion carried. Mr. Bushman asked for a motion to release the contract.

Irene McMullen moved and Jim McCaskey seconded to incorporate the comments of the prosecutor's office in the contract and send a clean copy to the Fire Department and to the other Trustees, with a unanimous vote. Motion carried.

# **CONTRACT FOR ADDITIONAL POLICE PROTECTION**

The Board addressed the not to exceed amount to be included in the contract with the Geauga County Sheriff for additional police protection.

Irene McMullen moved and Jim McCaskey seconded to enter into a contract for Sheriff's service for an amount not to exceed \$10,000, with a unanimous vote. Motion carried. PHONE SERVICE

The new phone system was installed for the Township and Fire Department. Mrs. Toth asked how the December bill was to be paid. The Trustees agreed to pay it from the General Fund. The Fiscal Officer will not be required to prorate the bill for the two departments. Mrs. Toth advised that she had already prepared the paperwork to prorate the bill from two line items in the General Fund. In 2019, she will pay the bill from one account.

Jim McCaskey moved and Irene McMullen seconded to pay the full bill for phone and internet, with a unanimous vote. Motion carried.

# **SCENIC RIVER**

Resident Marie Valince was present to discuss an email she sent to the Trustees regarding the field at Scenic River. She asked the Trustees if they wished to maintain a field or allow the area to grow naturally. Currently the area is mowed each fall, destroying the entire habitat. She suggested mowing a section each year on a rotating basis. The Trustees advised that they reviewed the conservation easement and conferred with the Western Reserve Land Conservancy, which holds the easement. They were concerned that the area would be overtaken by invasive plants if it was not mowed. They also did not recommend spring mowing. One option was to leave it unmowed in 2019 and to check for invasive plants in the fall of 2020. Mr. Bushman believed the Township had an obligation to maintain the habitats that were present when the property was purchased, such as the bobolinks'. The Board will ask for something in writing from the Western Reserve Land Conservancy. Ms. Valince brought up the hilly field on the east side. The Trustees told her it was mowed to be used for a sledding hill. The Trustees will ask the WRLC about the area between the hill and the lake.

# ADAM McKINNEY ALTERNATE WORK SCHEDULE

That the 2018 Budget and Permanent Appropriation be amended, as follows:

#### Additional Revenues to be Certified

To request the Budget Commission to certify additional revenues as follows:

In the General Fund: additional revenues collected for taxes and property tax allocation in the amount of \$9,000, UDLG \$7,600, grants and contributions \$5,632, insurance settlements \$3,937, and other \$26,000, for an <u>increase</u> in the General Fund in the amount of \$52,169;

In the Motor Vehicle License Tax Fund: \$2,100 for Sale of Fixed Assets, for an <u>increase</u> in the Motor Vehicle License Tax Fund of \$2,100;

In the Gasoline Tax Fund: \$7,200 for additional gasoline tax revenues, for an <u>increase</u> in the Gasoline Tax Fund of \$7,200;

In the Road and Bridge Fund: additional revenues collected for taxes and tax allocation in the amount of \$14,000 and Other Revenues in the amount of \$8,000, for an <u>increase</u> in the Road and Bridge Fund of \$22,000;
