Let the record reflect Jim McCaskey was sworn in by Geauga County Sheriff Dan McClelland prior to the meeting with his family members present. The meeting opened with the Pledge of Allegiance. Warrants11957-11967 dated 12/31/13 and 1/3/14 in the amount of \$9,880.85, EFT Vouchers 1-10 for the 1/3/14 bi-weekly payroll in the amount of 10,807.16, and Warrant 1171 dated 1/2/14 in the amount of \$6,145.13, to transfer EMS collections from the lockbox to the primary account, were signed. Correspondence was on the table.

ORGANIZATIONAL MOTIONS

Officers

Jim McCaskey nominated Irene McMullen for Chairman.

Andy Bushman moved and Irene McMullen seconded to close the nominations for Chairman, with a unanimous vote. Motion carried.

Mileage/Reimbursement/Allowances

Andy Bushman moved and Irene McMullen seconded to reimburse the trustees, fiscal officer, office manager, road superintendent, road foreman, and zoning inspector for long distance telephone calls made on township business, with a unanimous vote. Motion carried. Andy Bushman moved and Irene McMullen seconded that the Munson Township mileage reimbursement rate shall be equivalent to the current Internal Revenue Service rates when personal vehicles are used for township business outside the township for elected officials, and for township business anywhere for appointed officials and employees, with a unanimous vote. Motion carried. Let the record reflect the 2014 IRS rate for business is 56 cents per mile. Andy Bushman moved and Irene McMullen seconded to reimburse elected officials for year 2014 when a personal cellular phone is used for township business in compliance with the IRS regulations for reimbursement calculation; no roaming charges or other charges shall be reimbursed; requests for reimbursement shall be made monthly on a reimbursement form provided by the township to which a copy of the cellular bill has been attached, with a unanimous vote. Andy Bushman moved and Irene McMullen seconded to grant Munson Township Road Superintendent Jim Teichman a monthly cellular phone allowance for 2014 in the amount of \$100.00 per month to be included in his monthly paycheck; a copy of the cellular phone bill shall be submitted quarterly to the township fiscal officer, with a unanimous vote. Andy Bushman moved and Irene McMullen seconded to grant Munson Township Fire and EMS Administrator Mark Lynn a monthly cellular phone allowance for 2014 in the amount of \$100.00 per month to be included in his bi-weekly paycheck; a copy of the cellular phone bill shall be submitted quarterly to the township fiscal officer, with a unanimous vote. Motion carried. Andy Bushman moved and Irene McMullen seconded to grant Office Manager Paula Friebertshauser, Clerical Assistant Julie Johnston, and Zoning Inspector Tim Kearns a cellular phone allowance in the amount of \$10.00 per pay period for 2014 to be included in the employee's paycheck, with a unanimous vote. Andy Bushman moved and Irene McMullen seconded to allow township funds to be used to pay up to a 20% gratuity on meal bills when the meals are paid with or reimbursed from township funds, with a unanimous vote. Motion carried.

Jim McCaskey objected to the township's tradition of working on Veterans Day in order to take the time off the day after Thanksgiving. In deference to the veterans, he asked the Board to move another holiday. The Board discussed various options including an additional day off or giving a personal day the day after Thanksgiving. These options would require an amendment to the township personnel policy. For 2014, the Trustees agreed to allow the employees to work on Columbus Day and to use the holiday credit the day after Thanksgiving.

Jim McCaskey moved and Irene McMullen seconded that the ten legally recognized Year 2014 holidays will be News Years Day, Wednesday, January 1; Martin Luther King Jr. Day; Monday, January 20; Presidents' Day, Monday, February 17; Memorial Day, Monday, May 26; Independence Day, Friday, July 4; Labor Day, Monday, September 1; Columbus Day, Monday, October 13, observed Friday, November 28, the day after Thanksgiving; Veterans Day, Tuesday, November 11; Thanksgiving Day, Thursday, November 27; and Christmas, Thursday, December 25, with a unanimous vote.
