Meeting

The meeting was called to order at 6:30pm by Chairman Jim McCaskey with Trustees Irene McMullen and Andy Bushman and Fiscal Officer Judy Toth present. The Chairman led the Pledge of Allegiance. Warrants 16315-16320 dated 1/8/19 totaling \$9,700.80, EFT vouchers 1-9 for the 1/11/19 bi-weekly payroll totaling \$9,070.80, and Warrant 1287 dated 1/8/19 for \$4,029.50 to transfer EMS collections from the lockbox, were signed.

MINUTES

Andy Bushman moved and Irene McMullen seconded to approve the minutes of December 27, 2018, with a unanimous vote. Motion carried.

Andy Bushman moved and Irene McMullen seconded to approve the minutes of January 2, 2019, with a unanimous vote. Motion carried. Let the record reflect Mr. McCaskey is on the Board of Directors for Middlefield Bank.

BATTING CAGES

Students Cole Purchase, Rich Stefancic, and Evan Fairbanks requested authorization to install batting cages at the Munson Township Park as a senior project, to be located near the major league ball field. They had the endorsement of the Munson Park Board and passed out a map of the proposed location. A zoning certificate will not be required, as the batting cages will consist of a crushed limestone base, poles and netting, and are not considered a structure. The netting will be left up during the summer months and will be available for anyone to use. The Board discussed moving the nets a little closer to the other ball fields, making it more accessible, and placing it in a drier location. The zoning inspector and Chardon baseball will select the final location.

Andy Bushman moved and Irene McMullen seconded to allow the young men from Chardon Baseball to construct the baseball cages to be located at the Munson Township Park, with a unanimous vote. Motion carried.

PUBLIC COMMENT

Resident David Partington congratulated the Township on the rain garden grant. There was a nice article in the *Geauga Maple Leaf*. He offered his and wife Barbara's services for the project.

FIRE DEPARTMENT REPORT/CHIEF ALAN ZWEGAT

Chief Zwegat reported the fire department responded to approximately 1,100 calls last year. He will prepare a more extensive annual report. The fire department responded to a house fire on Mitchells Mill Road in Chardon Township caused by a lightning strike. He had three quotes for a security system for the fire department, to be installed as a permanent fixture to the building, and asked the Township to pay half the cost. He recommended Sievers Security who quoted \$7,169. Mr. McCaskey asked for an opportunity to review the quote. The Trustees suggested adding a camera at the front door.

NEW WELL

The Ohio EPA requested a written response regarding a temporary water source for the town hall. Mr. McCaskey prepared two responses. Option A proposed renting a temporary water tank at a cost of \$1,000 per month. Option B petitioned the Ohio EPA to allow the Township to use the Fire Department well, after testing the water quality, and to waive the requirement for a 24-hour pump test. The Board agreed to send Option B, followed up by a phone call. If the EPA does not accept this option, the Board will move forward with a temporary tank. The new well will take approximately four months due to the paperwork.

Andy Bushman moved and Irene McMullen seconded to authorize Jim McCaskey to sign for the new public water system application for the Town Hall, with a unanimous vote. Motion carried

Andy Bushman moved and Irene McMullen seconded to have Jim McCaskey sign the letter for Option B, with a unanimous vote. Motion carried.

RECYCLING CENTER

Mr. McCaskey notified Geauga Trumbull Solid Waste Management District that the Township is shutting down the recycling site. Geauga Trumbull will accept recycling at their new facility on Merritt Road. It will take approximately 6 months to get up and running. Royal Oaks asked Mr. McCaskey if the Township would consider leaving the cardboard dumpsters, and he told them no. Mike Dorka will be notified to remove the small appliance collection box.

Chief Zwegat reported Engine 4022 was back in service. Repair cost was approx. \$127. Four to five thousand dollars of warranty work was done. The Chief and Trustee Bushman attended Boy Scout Troop 91's Court of Honor Saturday. It was a great event with 75-100 persons in attendance including Judge Grendell. The Fire Department is hiring part time personnel and posted a notice on its Facebook page.
