Chairman Andy Bushman called the meeting to order at 6:30pm, with Trustees Jim McCaskey and Irene McMullen and Fiscal Officer Judy Toth present. Several members of the Fire Department were also present. Mr. Bushman led the Pledge of Allegiance. Warrant 15831 dated 6/22/18 for \$3,544.05 was signed at the June 12 meeting. The Board signed warrants 15832-15861 dated 6/26 and 6/29/18 totaling \$163,136.91 and EFT Vouchers 232-244 for the 6/29/18 monthly and bi-weekly payrolls totaling \$15,678.94.

FIRE DEPARTMENT REPORT/INTERIM CHIEF MIKE VATTY

The contractors completed the fire bay insulation last week. While the lift was available, the fire department repaired a damaged bar joist and replaced the ceiling fans. They attended the UHHS Geauga Hospital Safety Days, the in-service at the Mayfield Drive-in, and testing all day at the Notre Dame apartment buildings. They responded to 78 incidents, including four structure fires, one in Munson.

ROAD REPORT/SUPERINTENDENT JIM TEICHMAN

Full depth repairs on Heath Road were completed today, and paving will be done next week. The Township was notified that Windstream cancelled their bond. Mr. Teichman advised that utilities should be bonded to work in the Township road right-of-way. He met with the Ferlins on Fowlers Mill Road and put together specifications to replace the swale on their property. He had an aerial picture of what was there before construction. Mrs. McMullen suggested that the Board get a quote from a second vendor for lighting for the maintenance area and Mr. Bushman agreed to contact them.

LANDSCAPE PLAN

Mr. McCaskey will revisit landscaping for the Town Hall in the fall as he is focusing on a plan for the recycle area.

RECYCLING AREA

McCaskey passed out a plan to move the recycling area into the trees and farther away from the road entrance. The area will be blocked off by a six-foot fence. The Trustees asked resident Aaron Koehler for his reaction to the plan. He preferred that it be moved to another location, but recognized the need for recycling. He suggested that the Township restrict the hours to help with noise reduction, and increase the height of the fence. He asked about a block wall. Mr. McCaskey told him a shadow box wood fence would absorb more sound. Geauga Trumbull Solid Waste Management District will contribute toward the cost of construction but would require a commitment that the site remain open. Mrs. McMullen pointed out that if the construction is done by the Township, the site can be closed if necessary. The Township is also looking at other options. Two waste haulers have agreed to provide curbside recycling if there is a single hauler. Teichman noted that curbside recycling would make residents more accountable and cut down on abuse. The Board will make Mr. McCaskey's proposal available to the other affected residents to get their comments and suggestions.

MEMORIAL TREE

Pictures of the Condon memorial tree will be sent to the Park Board for their approval before the Trustees make a final decision.

INTERVIEWS FOR FIRE CHIEF

The Trustees were given an opportunity to interview the four candidates for the fire chief position. All of the candidates were interviewed by the Fire Department prior to that evening and ranked on their response to twenty questions. The Board asked candidates David Young, Alan Zwegat, Stephen Bohm, and Michael Santilli to wait outside the meeting room and called them in one at a time. Each interview lasted approximately 15-20 minutes.

At the conclusion of the interviews, the Trustees and Fire Department members reviewed the applicants.

2018 CAPITAL PROJECTS

The Board reviewed the funding available in the General Fund for capital projects, projected their costs, and advised which projects would move forward.

2019 BUDGET

The Board made one adjustment to the 2019 Budget.


