FIRE DEPARTMENT REPORT/CHIEF ALAN ZWEGAT

Chief Zwegat reported bucket truck 4044 is out for repairs. The repair is not under warranty. REGULAR BUSINESS

The Trustees will address motion activation for the maintenance building lighting, the agritourism application, the 208 Water Plan, and the Ohio Public Works Commission grant application at the May 28 meeting.

<u>HEALTH TRAIL SIGN</u> - At the last meeting, a question was raised if the sign, which identifies the end of the Munson Township Park vita course, was necessary. Mr. Bushman recommended that it be reinstalled.

<u>RAIN GARDEN SIGN</u> – Mr. Bushman will send Mrs. McMullen his recommendations for wording changes to the CRWP rain garden sign.

NOPEC GRANT/STREET LIGHTS

Andy Bushman moved and Jim McCaskey seconded to approve the LED upgrade for the sixteen streetlights on the Mayfield Road corridor not to exceed \$4,816, with both Trustees voting yes on the roll call. Motion carried. Mr. McCaskey signed the order.

TOWN HALL WELL UPDATE

Mr. McCaskey attended a sunshine law training today. He will check with the Prosecutor on what business the Board may conduct at a special meeting.

Andy Bushman moved and Jim McCaskey seconded to lease the Scenic River pavilion for the Klatka family reunion (Butler) on July 4, 2019 at noon for approximately 50 persons, and to waive the fees, with both Trustees voting yes on the roll call. Motion carried.
