#### RECORD OF PROCEEDINGS MUNSON TOWNSHIP TRUSTEES SPECIAL

Meeting

The special meeting was called to order at 6:30pm by Chairman Irene McMullen with Trustees Andy Bushman and Todd Ray and Fiscal Officer Patricia Bayer present. The Pledge of Allegiance was recited. Warrants 9928-9929 dated 11/10/11 totaling \$254.95 and EFT Vouchers 1864-1873 for the 11/10/11 bi-weekly payroll in the amount of \$10,450.52 were signed between meetings. The trustees signed warrants 9930-9968 dated 10/31/11 and 11/15/11 totaling \$75,936.15 and warrant 1120 dated 11/16/11 in the amount of \$10,961.66 to transfer EMS collections from the lockbox to the primary account. Correspondence and the fiscal officer's monthly report for October 2011 were available for review.

#### DRILLING WASTES AND FRACKING

Resident George Collins of 10461Wye Road presented his concerns about the impact of oil and gas well drilling on groundwater resources and Lake Erie. Fracking, the injection of water, chemicals and sand at high pressure in order to create fractures in the underlying geology to allow natural gas to escape, and the disposal of industrial wastes from oil and gas drilling into dry wells are both potentially harmful. Other states have outlawed the disposal of these wastes, which include hazardous materials and radioactive components, and they are being trucked into Ohio. Mr. Collins' goal was to get this issue to be heard in court regarding disposal of these wastes. If the case were initiated, he believes that federal prosecutors would take it over to protect our agreement with Canada for water rights to the Great Lakes.

#### OFFICE VOLUNTEER

The board addressed a request from Kristen Bluemmel to volunteer in the township office. Mrs. McMullen will contact the prosecutor's office regarding workers compensation. If workers compensation is not required, Ms. Bluemmel may begin volunteering as soon as she signs a general release form.

#### FIRE DEPARTMENT

Assistant Chief Mark Lynn asked the board to encumber an additional \$2,256.38 for the Tahoe command vehicle. Because the vehicle was already in production, the fire department was unable to change the color. He also discussed floor covering for the apparatus floor.

## RESOLUTION 2011-54/INHERITANCE TAX ADVANCE

Resolution 2011-54 was made by Mr. Ray and seconded by Mr. Bushman to request an advance of the inheritance tax collected during the month of October, with a unanimous vote. Motion carried.

#### APPOINTED BOARDS GIFT CERTIFICATES

Mr. Ray moved and Mr. Bushman seconded to approve gift certificates, in the amount of \$50 per member, for the Zoning Commission, Board of Zoning Appeals and Park Board, to be selected from Avalon Gardens, Bass Lake Taverne, Cottage Pottery, Four Green Fields, Fowlers Mill Golf Course, Ianiro's Bakery, Sage's Apples, The Fowlers Milling Company, or Western Reserve Farm Co-op, with a unanimous vote. Motion carried.

## CIC MEMBERSHIP

Mr. Ray moved and Mr. Bushman seconded to continue the township's membership in the Geauga Community Improvement Corporation [CIC] for 2012 for a \$50 fee, with a unanimous vote. Motion carried.

#### SUNSHINE SEMINAR

Mr. Ray moved and Mr. Bushman seconded to authorize Trustee Irene McMullen and Administrative Secretary Paula Friebertshauser to attend a Sunshine Law training seminar in Columbus on December 14, and to be reimbursed expenses, with a unanimous vote. Motion carried.

#### OTA WINTER CONFERENCE

Mr. Ray moved and Mr. Bushman seconded to authorize the elected officials to attend the Ohio Township Association Winter Conference February 8-11in Columbus, and to be reimbursed for all expenses, with a unanimous vote. Motion carried.

#### WEB/EMAIL HOSTING FEES

Office Manager Judy Toth informed the board that the township is exceeding the maximum capacity for web hosting and email and suggested that some of the pictures and older minute files be removed from the township web site. She also asked the trustees to look at their emails to see if anything could be purged. She advised that pairNetworks is offering a 24 per cent discount if the township pays for one year in advance in December and recommended that the board approve the expenditure.

#### TOWNSHIP HALL ADDITION PROJECT

Mr. Ray moved and Mr. Bushman seconded to approve a contract with Henry A. Penttila as architect for a base cost of \$52,000 for the building site plan and for the renovation and expansion of the Munson Township Hall, with a unanimous vote. Motion carried. The board agreed a \$3,000 retainer fee be prepared to Mr. Penttila for a time table schedule.

#### **EKLUND OHIO SENATE APPOINTMENT**

The board discussed the appointment of Munson resident John J. Eklund to the Ohio State Senate to replace Timothy Grendell. A resolution will be prepared for the next meeting.

### **EMPLOYEE EVALUATIONS**

The board discussed employee evaluations. The road superintendent will evaluate the road department employees and the fire chief will evaluate the fire prevention officer. The chairman will interview the office secretaries, Mr. Ray, will interview the road superintendent, and sit in on the road department members' evaluations, and Mr. Bushman will interview the zoning inspector, and sit in on the fire prevention officer's evaluation.

#### RESOLUTION 2011-55/FUND CERTIFICATION AND PLACEMENT

Resolution 2011-55 was made by Mr. Ray and seconded by Mr. Bushman to request the county auditor to certify additional inheritance tax received and to place it in various line items in the permanent appropriation and for within fund transfers in the Gasoline Tax Fund and Road and Bridge Fund, with a unanimous vote. ## RESOLUTION 2011-56/LGS CONTRACT FOR GASB FINANCIAL REPORTING

The board reviewed a contract from the Auditor of State's Local Government Services to prepare the 2011 GASB financial report at \$50 per hour for an estimated maximum of 16 hours. Local Government Services will not offer this hourly rate for less than a three-year contract. The township is not obligated to use their services for the second or third year.

Mr. Bushman moved and Mr. Ray seconded to enter into a contract with the Auditor of State's Local Government Services for GASB reporting at \$50 per hour not to exceed \$800 for year 2011, with a unanimous vote. Motion carried.

#### COMMUNITY ROOM RENTAL
