Road Department



With Fall upon us and Winter just ahead, we need to prepare for poor driving conditions. Slow down and drive defensively, not offensively.

Speaking of the fall with colors so vibrant, always remember that leaves can be slippery.

LEAVES - Leaves from residents' yards should not be raked or blown into the roadside ditch. Leaves plug the culverts, stopping the flow of water that leads to erosion and washouts of road edge berms, driveways, and sometimes roadways. The alternative is to compost the leaves and use the compost for flower beds and gardens next year.

<u>DRIVEWAYS</u> - New concrete or asphalt driveways are a great way to improve your property. If they are improperly installed, these driveway surfaces, especially at the adjoining road surface, in relation to finished height, may lead to many problems such as: water not pitched to flow to the ditch line and out into the road or berm, therefore causing a build-up in colder weather; and driveway ending height above the road edge may cause damage to snowplows and to the surface itself.

SNOW REMOVAL - Though prohibited by Ohio law, the practice of pushing snow across the roadway or out into the road and cul-de-sacs causing a hazard, still is a common practice by some. Please contact the responsible party at your residence and ask that this practice not continue.

Message From the Zoning Inspector

As the result of recent amendments to the Township Zoning Resolution (effective October 25, 2018) there are some revisions and additions to the Zoning Resolution that can effect both resident and business owner. Revised sections include the following:

- 202 Definitions of Principal Building, Yard, Setback Line and Sign.
- Flood Prone District-Intent and Purpose; 405.2 Conditional Uses; 405.3 Permitted Accessory Uses
- 507.4 Places of Worship
- 509.5 Accessory Structures; Fences, Gates and Walls
- 516.2 Storage of Construction Equipment and Other Large Vehicles; Other Vehicles
- 801.2 Conditional Zoning Certificates; Conditional Use Standards
- 804.6 Solid Mineral Extraction Operations
- 806.1 Flood Prone District Principal Buildings

The Munson Township Trustees are facing a hard decision regarding the recycling center. Many factors we have considered are the where, the why, the how, and the when. We have tried to make the best decision for all of the residents in the township. Other townships have closed their recycling centers, mostly due to the amount of maintenance they require and the number of unrecyclable items dropped off. County residents who use the recycling center located on Sherman Road need to realize what can and cannot be recycled. Items such as Styrofoam, toilets, trampolines, televisions, drum sets, football helmets, Christmas trees, plastic lawn furniture, plastic grocery bags, household trash, furniture, appliances, ceramics, and un-washed cans and bottles are not recyclable. Many of these items can be dropped off at the Munson Spring Clean-Up typically held the last Saturday in April. Please note that plastic grocery bags can be recycled at Giant Eagle in Chardon and Chesterland. There is also another drop off location for your recyclables at 470 Center Street in Chardon (County Offices).

There are other options available to residents to decide which plan works best for them. The information below states the cost of trash pickup and recycling (if available) from the local trash hauling companies in the area. We encourage residents to look at all of the options since curbside recycling pickup is also offered with trash pickup by some of the companies/haulers. It is the Trustees intention to close the recycling center at the end of the year if these problems remain unresolved.

Currently there are 4 residential garbage hauling companies who service Munson Township. We called for pricing in September which is reflected below. Munson Township is not responsible for any pricing discrepancies. There are different promotional specials that run throughout the year with some of the businesses listed.

<u>Chardon Disposal 440-669-3355</u> • \$25 per month, paying for 1 year in advance would cost \$275 per year. If you would like a garbage toter there is a one-time deposit of \$50. No recycle program is offered at this time. 10% Senior discount on monthly fee.

Major Waste 440-254-4929 • \$25 per month bagged (age 65+ \$20.50 -2 bag limit); \$26 per month with a 96 gallon toter (age 65+ \$21.50 with a 64 gallon toter). Toters have a one-time rental fee of \$25 (nonrefundable). No recycle program is offered at this time.

Rumpke 800-828-8171 • \$24.86 per month without a toter, \$28.86 per month with a toter. Recycle pick-up is an additional \$6 per month and you can add a recycle cart (blue) for an additional \$2 per month. If paying 1 year in advance: \$297.18 without a toter and \$346.12 with a toter. 10% Senior discount for trash service only.

Waste Management 844-492-9417 • Trash pickup only for approx. \$79.00 per quarter (toter included). Trash and recycle pick-up approx. \$110 per quarter. If paying 1 year in advance there will be a significant discount. No Senior Discount offered.

Message From the Fire Department ...



Greetings Munson residents,

Let me first take this opportunity to introduce myself as your new Fire Chief. My name is Al Zwegat and I have approximately 40+ years of Fire Service experience.

I have held every position in the Fire Service and worked my way up the ranks and retired as Fire Chief after a 38+ year career from the City of Willoughby Fire Department.

Over the course of my career, I have achieved multiple Ohio and National certifications and certificates along with attendance and course work from the National and Ohio Fire Academy's including National Fire Protection Association (NFPA) Fire Officer I, II, III certifications and various commendations.

My wife Connie and I are the proud parents of three children and reside in Geauga County.

It is my honor and privilege to be your Fire Chief. We at the Munson Fire Department look forward to serving you. If we can ever be of assistance, or if you have any questions or suggestions to help us serve you better, please feel free to stop by the fire station or give us a call at 440- 286-6797.

Kitchen Safety:

- Stand by your pan and create a child free zone and never leave cooking unattended.
- Turn the handles of pots and pans in and do not wear loose fitting clothing and keep combustibles away from cooking surfaces.
- Stove-top pan fires place a lid over the pot, pan or skillet and do not attempt to remove the pot/pan until it has cooled. If the fire does not extinguish call 911.



Home Safety:

- Assure that working smoke and carbon monoxide detectors are installed. At the minimum outside each sleeping area and on each level of your home. We would be happy to assist and help you evaluate your home needs.
- Never leave candles and/or smoking material unattended and never smoke in bed. Keep combustibles away from candles and extinguish when leaving the room.
- Have fire places and all heating appliances serviced by qualified technicians.
- Never refuel kerosene or gasoline powered equipment inside your home or basement.
- Assure adequate ventilation when using portable generators and never operate them indoors.
- Assure that outdoor furnace venting is clear of leaves and/or snow, to assure proper operation and exhaust of carbon monoxide.

Here is some additional Munson Fire Department information:

The Munson Fire Department is a full-service organization committed to reducing the risks to life and property in our community. This is accomplished through team work, training, preparedness and prevention. We are able to complete our mission, due to the support that we receive from you and our Township Trustees. We pledge to continue to deliver professional, cost-effective services in a personal, responsive and innovative manner that will always serve the public's best interest. The Munson Fire Department recently has been awarded an Assistance to Firefighters Grant for \$135,866.00 with a Township match of \$6,793.00, making the total grant award for \$142,659.00. Our Fire Prevention Program was also awarded a Grant in the amount of \$2,000.00 for the purchase of smoke detectors for our residential smoke detector program. Recently we also received a Grant from Covia/Best Sand, of approximately \$4,000.00 for the purchase of heavy rescue lift equipment. Your fire department will continue to seek alternative funding sources so that we will continue to provide the level of service our community expects and deserves. Hopefully, you will never require our assistance, but if you do, please be assured that we will be there for you.
