- (5) have not been convicted of a felony. All poll workers are required to attend a paid training class and are also paid to work on Election Day.

## **Country Living**

Munson Township is a growing community with many of the new residents coming from the city. City residents pay R.I.T.A. tax (Regional Income Tax Agency) which allows cities to offer many conveniences not offered in rural areas. Another convenience is city water and sewers. Many newcomers are not aware of the differences until they actually move here and find out the hard way. For most residents, this is old news.

One big misconception is a septic system. The typical septic tank is a large buried container made of concrete or fiberglass. Wastewater from the home flows into the tank. Heavy solids settle at the bottom where bacterial action partially decomposes them. Most of the lighter solids, such as grease and oils, rise to the top and form a scum layer. The wastewater leaving the tank is called effluent. One need is to pump the tank out according to how many people live in the house. A reputable septic tank cleaning company would be able to help you decide on the frequency of cleaning. Another need is to switch your leach fields. There is usually an upper and lower field; however, not everyone has a leach field. If you do, switching it twice a year is a good habit. One idea is to switch it when the time changes. The Geauga County Health Department (www.gphohio.org) is a great source for information.

Another misconception is storm sewers. Again, in the city there is a system of pipes and catch basins to take the water away from the houses and streets and deliver it eventually to Lake Erie. We rely on ditches and streams since we don't have storm sewers. Your pipes will take the downspout and footer tile water to the street or



more commonly into the woods and discharge it there. If your basement is lower than the street or woods, you will most likely have a sump pump to pump that footer tile water away from the basement. It is a good idea to know where your footer and downspout drain tile discharge so you can keep the area clear of debris. If the pipe discharges into the ditch at the street and the ditch gets full of debris, (sticks, leaves, silt, etc.). Please call Town Hall and the Road Department may be able to help you out. Residents can also put a slotted cap over the discharge pipe or 'one way valve' to keep animals out of the pipe.

Lastly, your well will need to be chlorinated once in a while to keep coliform bacteria from getting into your home; http://gphohio.org/ Environmental-Health/Private-Water-Wells is the perfect website to visit to answer your questions. ## Are You Thinking of Enclosing Your Ditch?

Many residents enclose their ditch to make cutting grass easier or to add curb appeal to their home. If you are thinking of making this improvement, there are a couple of steps required by the Township before doing so. Most residents hire a

landscape company but some take the task on themselves. A permit for only \$2 submitted with a sketch/drawing is required by the Township. Road Superintendent Kirk Walker must approve the permit before moving forward. Kirk must also inspect the area prior to the ditch being enclosed with the top dressing. ## Message From the Fire Chief...

# ARE YOU PREPARED?

Considering the state of our country with the Corona Virus, more people are home or have been home now more than ever. Working from home or attending school from home has been and seems to be part of the norm. Are you protected? Does your home have the most trusted smoke detectors? Almost 40 years of research has shown that the most popular smoke alarm which is in 90% of homes in America is failing at an alarming rate.

These ionization smoke alarms are alerting tens of minutes slower than the other type, **photoelectric** smoke alarms, in the deadly smoldering stage of a fire. They are also more prone to nuisance false alarms from ordinary cooking and steam from showers.

**Photoelectric** smoke alarms sound tens of minutes faster than ionization smoke alarms during smoldering stage fires with significantly fewer false alarms. Furthermore, their performance in flaming stage fires is comparable to ionization alarms, making the **photoelectric** alarm the <u>best</u> choice.

For your safety and the safety of your entire family, recommendations by the North Eastern Ohio Fire Prevention Association and firefighters across the state of Ohio is for you to check what type of smoke alarms you have in your home.

It's easy! Just check the front or back of the alarm for the word "**Photoelectric**" or the letter "**P**" or the word "Ionization" or the letter "I". Any indication that your smoke alarm contains radioactive material also indicates that it is an ionization alarm. And while you're checking, look for the date of manufacture on your alarm. Smoke alarms expire 10 years after the date of manufacture and need to be replaced.

If you have ionization smoke alarms, change them out as soon as possible! **Photoelectric** alarms are sold in most major hardware stores. Just look for the word **photoelectric** or the letter "**P**" on the packaging.

Oh, and what about those dual-sensor alarms that contain both photoelectric and ionization sensors? They cost twice as much and still generate all those nuisance false alarms!



Current emergency call volume is back to normal. Fire inspections are back on track and Munson Fire Department is completing fire inspections before our schools reopen. Many changes have taken place in the public and private sector; with more to come. Your fire department is managing and will continue to manage whatever is thrown our way.

### Have and Practice a Fire Escape Plan

- 1. Know at least two ways out from every room or space in your home.
- 2. Crawl low in smoke. Smoke rises so the air near the floor will be clearer.
- 3. **Feel doors before opening them**. If the door is hot, do not open it. If the door is cool, stay low as you open it. There still may be heat, smoke or fire on the other side.



4. **Leave immediately**. Don't stop for anything. No possessions are worth your life.

5. If you cannot leave a room, make sure the door is closed and go to the window. Open it or break it out and exit if you can. If you can't exit the window because it's too high, use a bedsheet, towel, etc. to wave and yell to attract attention. If necessary, use towels, clothing, pillows, etc. to block smoke coming through door cracks or vents.

6. **Have a family meeting place outside**. Count to ensure everyone is out safely.

7. **Once you are out, stay out**. Never go back inside for anyone or anything.

8. **Call the fire department** once you are out safely. The emergency number is 911. Call from a neighbor's home or a cell phone.

Fire Department Hours: Mon. – Fri. 8:00 a.m. to 4:00 p.m. The station is staffed 24/7 to assist you.

## **CARES Act Pandemic Relief Funds**

Like all local government entities, Munson Township has received Federal funding to help offset costs associated with responding to the COVID-19 disease and steps taken to limit its spread in the community. The first funding arrived in the form of what is called the Provider Relief Fund. Munson received a direct payment of \$7,593.00, in April. These dollars are intended to support the direct-care providers who diagnose, test, or care for individuals with possible or actual cases of COVID-19. The Trustees have set aside these funds, and they will only be spent to reimburse Munson Fire Department for unanticipated expenses unique to the COVID-19 exposure threat, such as the personal protective equipment necessary for the protection of the staff members.

The second round of funding arrived in June. Munson received \$74,111.00, available to offset spending for a wider range of costs that communities have taken on due to the pandemic. In addition to such things as more frequent and robust cleaning and sanitization of Township facilities, these CARES Act funds can be spent on such things as HVAC ventilation/purification equipment upgrades in public spaces, installation of touch-free water fixtures, plexi-glass space dividers, and equipment and subscription services needed for virtual teleconferencing of public meetings.

To promote the wise use of these resources, all CARES Act funds come with specific conditions that the Trustees must consider and apply when authorizing any expenditures, and all spending will be audited in the Township's next biennial audit.
