Chairman Andy Bushman called the meeting to order at 6:30pm with Trustees Jim McCaskey and Irene McMullen and Fiscal Officer Judy Toth present. Mr. Bushman led the Pledge of Allegiance. The Board signed warrants 16152-16165 dated 11/5/18 totaling \$13,050.61.

#### **BASEBALL FIELD PREP**

The Trustees received a quote of \$1,500 per ball field from P. laniro Lawn and Garden to prep up to three ball fields in the fall if weather permits.

Mrs. McMullen moved and Mr. McCaskey seconded to authorize P. Ianiro Lawn and Garden to renovate and prepare Munson Fields 1, 2, and 3 for an amount not to exceed \$1,500 apiece, with a unanimous vote. Motion carried. The baseball organizations will hold a joint meeting at the high school on November 12. Mr. McCaskey asked if either Trustee could attend the meeting if he was unable, and Mr. Bushman said he could.

#### 2018/2019 TRAPPING SEASON

Irene McMullen moved and Jim McCaskey seconded to authorize Adam McKinney to continue trapping for the 2018/2019 season on Township Park property, with a unanimous vote. Motion carried.

#### **SQUAD 4052 REPAIR**

Mr. McCaskey reported that Preston negotiated with Ford to pay up to \$10,000 for their half of the repairs to Squad 4052, and he expressed his gratitude to Pat Preston for his efforts on behalf of the Township.

## **BINGHAM FOUNDATION**

Mrs. McMullen asked if the Trustees wished her to pursue a grant from the William Bingham Foundation to install a rain garden in a low spot at the Munson Township Park. She suggested shrubs, as they will be lower maintenance.

#### **NERO PARK VANDALISM**

Nero Park was vandalized over the weekend. Grounds were turfed and graffiti was painted on the transformer box. Upon hearing of the incidents, Mr. McCaskey asked the road superintendent to lock the gate to the entrance for the winter. The vandalism will be reported to the sheriff.
