

Munson Township Park & Recreation Board Meeting

Wednesday, July 15, 2009

The meeting was called to order at 5:32 p.m. by Chairman Rosboril.

Present: Kristen Bluemmel, John Kaczynski, Tim Kearns, Barbara Parkinson, Michael Payne, Michael Roche, Joe Rosboril, Jonathan Schroeter, Mark Stukbauer. Absent: Patricia Palcic. Others in attendance: Andy Bushman, Dave Baird, Paula Friebertshauser.

Minutes

The minutes of the June 24, 2009 meeting were approved 8-0-1 (Bluemmel).

Tennis Courts

Dave Baird attended to explain the problems with the tennis courts' surface; his company did the repair job of the cracks, etc. on the surface. It was noted that the asphalt pad cracked over the winter. Possible reasons are drainage problems under and/or around the courts and the unknown substructure/ground conditions under the courts when they were installed. Baird will touch up the cracks, but there is no guarantee of the permanency of the repair. He will monitor the cracks to work with us to better understand future repair options.

Community Day Picnic

Paula Friebertshauser passed out the layout for this year's picnic; similar to last year's layout. There are new information vendors who will be present - UHHS and Lions Football Club. A church requested permission to pass out literature; a consensus was to deny this request. The booths are (refer to layout) 1) Benjamin Franklin who will be making kites; 2) Munson Township Recreation & Park Board who will hand out literature, survey, and offer the bottle game; 3-6) kids' games; 7) UHHS; 8) Mental Health; and 9) Lions Football Club.

The 5K run has been cancelled, but plans are to still have the Fun Run. The dinosaur eggs will be used for a toddler game - digging in sand or other medium for the prizes. We will offer recycling of cans and bottles in specially marked containers. The donation list was passed out; board members volunteered to contact many of the businesses that need contacting and/or follow up; the electric is in for the sound system and the inflatables.

Brochure

The second version of the brochure by Andy Bushman was passed out for comments, proofing, etc.

Flag Pole

There were two quotes; the best from K.E.S. Co. Rosboril moved, seconded by Kaczynski, to take the request to the Munson Township Trustees. Passed unanimously.

Stamped Concrete

Rosboril researched stamped concrete for the three paths around the pavilions at Scenic River Retreat; best price was \$10,500. Kearns moved, seconded by Schroeter, to take the monetary request to the Munson Township Trustees. Passed unanimously.

Dog Poop

Kearns described a situation he observed at Scenic River Retreat concerning people allowing their dogs to run free, making a mess along the way. He found out that we can prosecute if we see people permitting their dogs to mess without cleaning it up - need car license numbers, etc. Kearns will research information about doggie bag dispensers to install at all our parks.

Munson Township Trustees Actions

The Trustees approved \$1,000.00 for gravel for the Munson Township Park to be installed prior to the Community Day Picnic.

Open Discussion

Speed bumps have been installed at the Munson Township Park; several members noted that the speed of park users has been reduced. Kearns researched speed bump manufacturers and found a manufacturer on Munn Road - they recommended their 9-foot plastic with a 5-year guarantee at \$130.00 each. Kearns moved, seconded by Roche, that we ask the Munson Township Trustees for \$1,300.00 for five sets of bumps. Passed 7 - 1 (Stukbauer) - 1 (Parkinson).

Adjournment

The meeting was adjourned at 7:00 p.m.

The next meeting will be Wednesday, August 5 at 5:30 p.m. at the Munson Township Park for last minute business about the Community Day Picnic. We will also meet at the Munson Township Park on Friday, August 14 at 5:00 p.m. to help with last minute set-up for the Community Day Picnic.

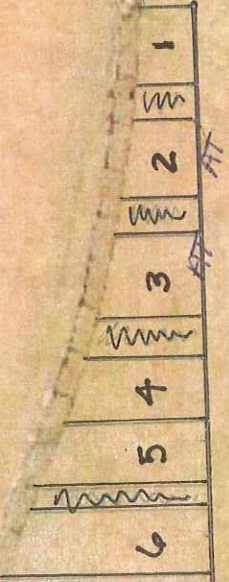
