Held Tuesday, August 14, 20 12

The meeting was called to order at 6:30pm by Chairman Todd Ray with Trustees Andy Bushman and Irene McMullen present. Mr. Ray noted that there was correspondence available for review and warrants were being signed by the trustees [warrants 10607-10649 dated 7/31 and 8/14/12 totaling \$31,275.79]. Mr. Ray also noted that Judy Toth experienced a flight delay and then a traffic jam, but that she would get to the meeting as soon as she could. The minutes were taken by Trustee Irene McMullen until Mrs. Toth's arrival at 6:47pm.

KLINGMANN PROPERTY 13417 ROCKHAVEN ROAD

Chairman Ray asked if there was any public comment. Kris Klingmann spoke regarding the progress he has made with the demolition plans relating to his property. Andy Bushman spoke with Bainbridge Township, and they are sending him the procedure relating to the Ohio EPA grant received by Geauga County and administered by Bainbridge, that may potentially reimburse Munson for any funds expended relating to the demolition. Bainbridge is administering the expenditure of about \$470,000 in funds. The turnaround time for reimbursement should be less than 30 days, so Munson may be able to get reimbursement before any bills are due. Andy will coordinate getting the documentation together that Munson will need to consider applying for grant funding by the next regular meeting on August 28. Regarding scheduling, Mr. Klingmann indicated that Cherokee Abatement, a potential asbestos removal contractor, can perform their work in two working days. The Ohio EPA needs two weeks (10 working days) notice before abatement. Mr. Klingmann will contact Bert Mechenbier at the Ohio EPA to confirm that the flooring does not need to be abated.

BID OPENING FOR MICROSURFACING

At 6:45 PM, bids relating to micro-surfacing were opened. Two sealed bids were received. . Andy Bushman moved that the reading of the public notice be waived. Irene McMullen seconded the Motion. All trustees voted yes. Motion carried.

Andy Bushman opened the bid from American Pavement Inc. in the amount of \$110,910.00, bid bond from Merchants Bonding Company (Mutual) enclosed.

Todd Ray opened the bid from Strawser Construction, Inc. in the amount of \$98,526.00, bid bond from Liberty Mutual Insurance Company enclosed.

Andy Bushman moved that the trustees would turn the bids over to the County Engineer for review. Motion seconded by Irene McMullen. All trustees voted yes. Motion carried. Mrs. Toth joined the meeting at 6:47pm.

TOWNSHIP HALL PROJECT

At the last meeting, the board discussed proceeding with the project without a complete site plan. It was thought to be an option because the site was flat. Architect Hank Penttila walked the property, took field measurements, contacted the zoning office for existing engineering plans, and looked at the temporary gravel road. He discovered quite a bit of variation in topography and improvements that were made for which there was no documentation. Based on his review, Mr. Penttila recommended that the civil engineering be done before bidding out the project. There may also be drainage issues that need to be addressed. Mr. Penttila employed several persons at his expense to review the fire station roof, and was close to a recommendation. He discussed the two purposes of a roof, waterproofing and water-shedding, and was committed to finding a lasting solution. The old roof will open into the new construction to provide ventilation. Because of this there will be no benefit in extending the rake out further as was originally planned. He recommended preparing an extra drawing for the roof, as an alternate, to identify the base bid for roof replacement, and the cost to do it in a longer lasting solution. Mr. Penttila reviewed the three firms under consideration for civil engineering, and recommended Stephen Hovancsek and Associates. He has also worked well with Land Design and found both to be professional firms. He will request a revised quote, and the board agreed to meet next Tuesday to approve the civil engineer. Mrs. McMullen was not able to attend the meeting, but was supported moving forward with the site review as quickly as possible. The board discussed a bidding timetable. The architect advised that the project can be divided into three segments, roof, interior renovation, and new construction. The roof and interior renovation are not affected by the weather and may be done in the fall. The new construction can wait for spring. He suggested that all three segments be bid together and that the bid package specify for how long the bid is good. He expected prices to be stable through the winter.

Andy Bushman moved and Irene McMullen seconded to hold a special meeting for the discussion of civil engineering on August 21, 2012 at 6:30pm, with a unanimous vote. Motion carried.

FIRE DEPARTMENT

Fire Chief Mark Lynn advised the township received an offer of \$1,900 from Montville Township for the 2002 Ford Explorer.

Andy Bushman moved and Irene McMullen seconded to authorize the sale of the 2002 Ford Explorer to Montville Township for \$1,900, with a unanimous vote. Motion carried. Chief Lynn was concerned about a leak in the bay close to the electric panel and asked the road department to look at it. He reported that the Ohio EPA has lifted the ban on open burning. In October, Munson Firefighter/EMT Mike Swanker will be leaving for the Army Reserves to serve as a medic, and will be gone for 22 weeks. Peace Lutheran Church asked the fire department for assistance to erect a banner across Bass Lake Road for their festival next month. Mrs.

McMullen asked him to make sure that Peace Lutheran had met all zoning and state requirements before offering their assistance. The new squad is in service. University Hospitals – Geauga donated a new LifePak defibrillator to the fire department, valued at \$25,000.

RESOLUTION 2012-40 – RETIREMENT OF FIRE CHIEF BERNIE HARCHAR

The board presented a resolution of appreciation to retiring Fire Chief Bernie Harchar. Resolution 2012-40 was made by Andy Bushman and seconded by Irene McMullen to commend Fire Chief Bernie Harchar for his service to Munson Township as a firefighter volunteer and officer beginning in 1988, and as fire chief from 1992 to 2012, guiding the fire department through its growth from a partly volunteer operation to a professional organization with round the clock staffing, and for his leadership services to the extended community, with a unanimous vote. RESOLUTION 2012-41 – PATRICIA HARCHAR

Resolution 2012-41 was made by Irene McMullen and seconded by Andy Bushman to commend Patricia Harchar, spouse of Bernie Harchar, for her volunteer service to the fire department, and for the personal sacrifices she has made to support Bernie's commitment to the fire department, with a unanimous vote. The meeting recessed at 7:25pm for refreshments and resumed at 7:35pm.

PARKS

The Trustees addressed a memo from the Park Board requesting \$8,000 for additional mulch for the park playground and vita course.

Andy Bushman moved and Irene McMullen seconded to encumber \$8,000 to Ready to Haul for an additional 300 yards of playground mulch, with a unanimous vote. Motion carried.

ROAD REPORT

Road Superintendent Jim Teichman reported road resurfacing will begin tomorrow and will be done by Saturday, weather permitting. Roads scheduled for striping, will be striped.

RESOLUTION 2012-39 - FUND TRANSFER

Resolution 2012-39 was made by Andy Bushman and seconded by Irene McMullen for a within fund transfer in the General Fund in the Permanent Appropriation, with a unanimous vote. Motion carried. [The resolution in its entirety is included on a separate page as part of the minutes.]

OFFICE MANAGER PROBATION PERIOD

The probation period for office manager Paula Friebertshauser has ended and the board addressed a salary increase. Mrs. McMullen suggested that a board member meet with her and Chairman Ray agreed to set up a meeting.

Andy Bushman moved and Irene McMullen seconded to change Paula Friebertshauser's hourly rate to \$24.25, with a unanimous vote. Motion carried.

Andy Bushman attended Safety Council meeting on August 3 and Andy Bushman and road department employee Adam McKinney attended a workers' compensation safety seminar on August 14. The budget hearing for the 2013 Budget will be Thursday, August 16 at 2pm at the County Auditor's office. Andy Bushman and Judy Toth will attend.
